- 1) We are charging fees to Reserve Category students as per the guidelines and directives of State CET Cell, DTE and Social Welfare Department (Government of Maharashtra). However, it shall be the responsibility of the student to submit their Scholarship application form to the concern Government Authorities within the prescribed time limit or dates for the sanction. The Institute shall not be responsible for the failure in submission of application form and for the non-sanction of the same from Government Authorities. **In such circumstances students will have to pay the balance fees to the Institute before the completion of first year of course.**
